Dear Mr. Hart and Mr. Sohn:

Please be advised that your 2016 M2 Campaign Treasurer's Reports, covering the period 2/1/2016 – 2/29/2016, have been received. Upon review of the documents, they are deemed to be incomplete and have been accepted on a conditional basis.

The first document is identified as 2016 G6, covering the period 2/13/2016 – 2/26/2016. This report also contains a Campaign Treasurer's Report – Itemized Distributions, which form is used to report distributions of goods or services contributed to a candidate or committee, indirect expenditures and reimbursements. The Tamara James Foundation is not a candidate or committee; if you made a donation to the Tamara James Foundation, it should be listed on the Campaign Treasurer's Report – Itemized Expenditures form.

The second document is a Waiver of Report, Monthly Report, G4, Termination Report, covering the period 2/1/2016 – 2/12/2016.

If you are terminating your campaign, you need to submit a Termination Report (TR), which report must show how the remaining campaign funds have been expended. This report would include the Campaign Treasurer's Summary, Campaign Treasurer's Report – Itemized Expenditures, and Campaign Treasurer's Report – Itemized Contributions, if applicable. Your Total Monetary Contributions to Date, and Total Monetary Expenditures to Date, must equal the same amount.

To date, you still have not submitted your 2015 M7, 2015 M8, or 2015 M9 Campaign Treasurer's Reports. Whether or not you terminate your campaign, these reports must also be filed.

The \$297.50 fine for the 2015 M6 Campaign Treasurer's Report has not been received by the City. Payment of this fine must come from the candidate's personal funds; not the campaign account. Additional fines will be imposed for the late filing the 2015 M7, 2015 M8, and 2015 M9 Campaign Treasurer's Reports once they are received.

You have seven (7) days from receipt of this letter to submit an addendum to the 2016 M2 report. Failure to file a complete report within seven (7) days of receipt of this notice constitutes a violation of Chapter 106, Florida Statutes.
