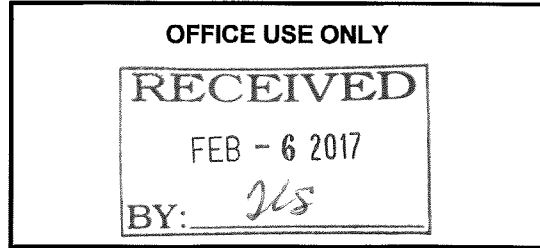


I am submitting a revised G7 report for the reporting period of 10/22 thru 11/03.
