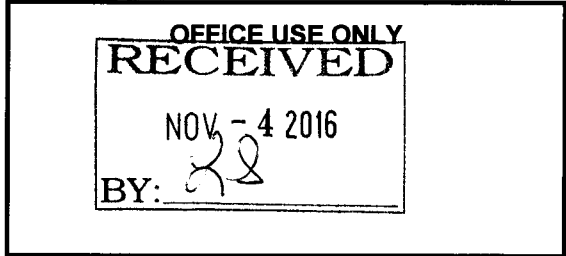




Dear Louise Stilson,
